



Publication Ethics and Publication Malpractice Statement

Ideas Forum International Academic and Scientific Association (IFIASA) provides a platform for the latest scientific, theological, philosophical and moral-educational research, encouraging approaches from different areas and points of view. *Ideas Forum International Academic and Scientific Association* is an independent academic publisher with an editorial team comprising many of the world's leading researchers. In the context of the current international framework, IFIASA journals and Conferences joins the effort in bringing together researchers and scientists from all over the globe, facilitating the professional development and encouraging dialogue, creativity and exchange of ideas.

For all parties involved in the act of publishing (the author, the Journals editor(s), the peer reviewer and the publisher) it is necessary to agree upon standards of expected ethical behavior.

Duties of the Editors-in-Chief

Submitted manuscripts are evaluated for their intellectual content without regard to race, gender, sexual orientation, religious belief, ethnic origin, citizenship, or political philosophy of the authors.

Confidentiality

The Editor-in-Chief and any editorial staff must not disclose any information about a submitted manuscript to anyone other than the corresponding author, reviewers, potential reviewers, other editorial advisers, and the publisher, as appropriate.

Disclosure and conflicts of interest

Unpublished materials disclosed in a submitted manuscript must not be used in an Editor's own research without the explicit written consent of the author(s).

Publication decisions

The handling Editor-in-Chief of the Journals is responsible for deciding which of the submitted articles should be published. The Editor-in-Chief may be guided by the policies of the Journals Editorial Board and constrained by such legal requirements as shall then be in force regarding libel, copyright infringement and plagiarism. The Editor-in-Chief may confer with other editors or reviewers in making this decision.

Duties of peer reviewers Contribution to editorial decisions

Peer review assists the Editor-in-Chief in making editorial decisions and, through the editorial communication with the author, may also assist the author in improving the manuscript.

Any invited referee who feels unqualified to review the research reported in a manuscript or knows that its timely review will be impossible should immediately notify the Editor-in-Chief so that alternative reviewers can be contacted.





Confidentiality

Any manuscripts received for review must be treated as confidential documents. They must not be shown to or discussed with others except if authorized by the Editor-in-Chief. Standards of objectivity Reviews should be conducted objectively. Personal criticism of the author is unacceptable. Referees should express their views clearly with appropriate supporting arguments.

Publication and authorship

All papers sent for publication should include professional title, didactic position, institutional affiliation, contact information and email address of the author(s). In order to send a material for publication in the IFIASA Journals & Proceedings, one must assume the fact that this material has never been published and neither is sent for publishing anywhere else. It is forbidden to publish the same article under the same title or even under a different title in another journal.

Authors are invited to submit original and previously unpublished papers.

The IFIASA Journals & Proceedings follows a systematic review and publication policy. The practice of peer review is to ensure that good paper is published. It is an objective process at the heart of good scholarly publishing and is carried out on all reputable scientific Journals. Our referees therefore play a vital role in maintaining the high standards of IFIASA.

All submitted manuscripts to the IFASA Journals & Proceedings are subject to strict peer-review process.

IFIASA Proceedings operates a double-blind peer review process.

To facilitate this process, authors are requested to ensure that all references to their own previously published work are impersonal.

Reviewers are selected by the editor in chief, after consultations with the members of the editorial board.

The editors will send authors a delivery receipt when manuscripts are received. Please note that the peer-review process might take, in some cases, 1 to 2 months. Authors will be notified of acceptance for publication as soon as reviewers' answers are received.

Accepted articles are usually published in the forthcoming issue of the journal.

If the reviewers opinions are significantly divergent, a third reviewer will be asked to read the manuscript. Authors might be required to revise the manuscript according to the recommendations of the reviewers.

Revised manuscripts should be accompanied by a point-by-point reply to the recommendations of reviewers, specifying the changes made in the revised version or the reasons why authors decided to reject reviewers' recommendation(s).





The factors that are taken into account in review are relevance, soundness, significance, originality, readability and language.

The possible decisions include acceptance, acceptance with revisions, or rejection.

If authors are encouraged to revise and resubmit a submission, there is no guarantee that the revised submission will be accepted.

Rejected manuscripts will not be re-reviewed. The manuscript acceptance is constrained by such legal requirements as shall then be in force regarding libel, copyright infringement and plagiarism.

No research can be included in more than one publication.

Authors' responsibilities

Authors must certify that their manuscripts are their original work.

Authors must certify that the manuscript has not previously been published elsewhere.

Authors must certify that the manuscript is not currently being considered for publication elsewhere.

Authors must participate in the peer review process.

Authors are obliged to provide retractions or corrections of mistakes.

All Authors mentioned in the paper must have significantly contributed to the research.

Authors must state that all data in the paper are real and authentic.

Authors must notify the editors of any conflicts of interest.

Authors must identify all sources used in the creation of their manuscript.

Authors must report any errors they discover in their published paper to the editors.

Reviewers' responsibilities

Reviewers should keep all information regarding papers confidential and treat them as privileged information.

Reviews should be conducted objectively, with no personal criticism of the author.

Reviewers should express their views clearly with supporting arguments.

Reviewers should identify relevant published work that has not been cited by the authors.

Reviewers should also call to the editor-in-chief's attention any substantial similarity or overlap between the manuscript under consideration and any other published paper of which they have personal knowledge.

Reviewers should not review manuscripts in which they have conflicts of interest resulting from competitive, collaborative, or other relationships or connections with any of the authors, companies, or institutions connected to the papers.

Editors' responsibilities

Editors have complete responsibility and authority to reject/accept an article.

Editors are responsible for the contents and overall quality of the publication.

Editors should always consider the needs of the authors and the readers when attempting to improve the publication.

Editors should guarantee the quality of the papers and the integrity of the academic record.

Editors should publish errata pages or make corrections when needed.

Editors should have a clear picture of a research's funding sources.

Editors should base their decisions solely on the papers' importance, originality, clarity and relevance to publication's scope.

Editors should not reverse their decisions nor overturn the ones of previous editors without serious reason.

Editors should preserve the anonymity of reviewers.

Editors should ensure that all research material they publish conforms to internationally accepted ethical guidelines.

Editors should only accept a paper when reasonably certain.

Editors should act if they suspect misconduct, whether a paper is published or unpublished, and make all reasonable attempts to persist in obtaining a resolution to the problem.

Editors should not reject papers based on suspicions, they should have proof of misconduct.

Editors should not allow any conflicts of interest between staff, authors, reviewers and board members.

Authors are not required to pay an Article Submission Fee as part of the submission process to contribute to review costs.

Print & Open access fees

In order to provide open access, our journal uses a business model to offset expenses, by charging an open access fee to the authors, institutions or funders for each article published. These fees include those of the journal's production, online hosting and archiving.

The ability of authors to pay the open access fee does NOT influence the peer review process. No fee can be paid prior to the final positive decision of the reviewers and the editor in charge, regarding the article proposed to be evaluated in order to be published.

Exceptionally, authors from developing countries may propose a grant application to the administrative board, for partially covering this open access fee.

Depending upon each particular case, the fee can be covered by the IFIASA Association, the governing body of our journals.

1. As a participant registered with paper(s); fee is 110 Euro for each paper, + 10 Euro for print paper and courier tax; second paper will receive also 15% discount. Other discounts are offered for former participants and best paper.

2. (30%) fee back as a reviewer, with a CV that pointed you as specialist in one of the domains mentioned in our aim (<http://ifiasa.org/MCDSARE-JOURNAL/>);

3. The best paper will be awarded half (40%) fee back.

4. The IFIASA conference accepts original, previously unpublished works. An author can only receive one publication grant per year. If you do not have funds to pay such fees, you will have an opportunity to waive each fee. We do not want fees to prevent the publication of worthy work.

Plagiarism

All articles published by IFIASA Journals & Proceedings are committed to publishing only original material, i.e., material that has neither been published elsewhere, nor is under review elsewhere. Manuscripts that are found to have been plagiarized from a manuscript by other authors, whether published or unpublished, will incur plagiarism sanctions.





The editorial board is very strict regarding plagiarism. The IFIASA believes that taking the ideas and work of others without giving them credit is unfair and dishonest. The editorial board retains the absolute authority to reject the review process of a submitted manuscript if it is suspect at plagiarism or subject to plagiarism.

Duplicate Submission

Papers that are found to have been published elsewhere, or to be under review elsewhere, will incur duplicate submission/publication sanctions. If authors have used their own previously published study, or study that is currently under review, as the basis for a submitted manuscript, they are required to cite the previous paper and indicate how their submitted manuscript offers novel contributions beyond those of the previous work.

Citation Manipulation

Submitted papers that are found to include citations whose primary purpose is to increase the number of citations to a given author's article, or to articles published in a particular Journal, will incur citation manipulation sanctions.

Data Fabrication and Falsification

Submitted papers that are found to have either fabricated or falsified experimental results, including the manipulation of images, will incur data fabrication and falsification sanctions.

Improper Author Contribution or Attribution

All listed authors must have made a significant scientific contribution to the study in the paper and approved all its claims. It is important to list everyone who made a significant scientific contribution, including students and laboratory technicians.

Redundant Publications

Redundant publications involve the inappropriate division of study outcomes into several articles.

Copyright

The authors will take into account the compliance for the copyright of the visual materials (e.g. pictures) sent for publishing.

The Journals by IFIASA holds the copyright for the published materials.

The authors are have the right to use, partially or totally, the published material for preparing other personal projects, by mentioning the coordinates of the original publication.

The studies/articles or the translations published in the Journals by IFIASA can be used in the content of some collective or reverential volumes, edited under the aegis of the Editing Office „IFIASA”.
